

## Carlson Rezidor announces the Park Inn by Radisson Hotel Bahrain

It is the second hotel for Carlson Rezidor in the Kingdom following the successful Radisson Blu Diplomat Hotel, Residence & Spa, Manama, which opened in 2000. The government of Bahrain is currently taking steps to diversify its economy and has established the country as a regional hub for the rapidly growing Islamic finance industry.

The Park Inn by Radisson Hotel Bahrain will be well located in Manama's AI Seef District with waterfront views. It will be 10km away from the airport and only 6km from the Diplomatic Quarter which houses the Radisson Blu hotel. Besides 207 guest rooms, the new hotel will offer a 215m<sup>2</sup> all-day dining restaurant with terrace and a 420m<sup>2</sup> outdoor roof bar, meetings and events facilities spread over 510m<sup>2</sup> as well as a gym and pool (360m<sup>2</sup>).
